Release of Claims & Liabilities for Humanitarian Organizations

This form must be completed and returned to Gleaning For The World, Inc. annually to receive donations.

Gleaning For The World, Inc. is a non-profit corporation that receives and distributes food, clothing, medical supplies, and medical equipment to mission and humanitarian organizations in the United States and around the world. The products and supplies are received as a donation from various industries and are prepared for distribution. It is the responsibility of Gleaning For The World, Inc. to receive, prepare, and load the trucks and/or containers for shipping the donated products.

Once an agreement is completed regarding a load of materials, the receiving organization has two weeks to provide a truck or ocean-going vessel for the load to be removed. Beyond that period, the consignee will be asked to reimburse Gleaning For The World, Inc. for storage at a rate equal to the storage rate in the Lynchburg area.

In recognizing that Gleaning For the World, Inc. is a non-profit Christian ministry, we request every organization or individual to sign and date this "Release of all Claims and Liability." All products donated by Gleaning For The World, Inc. to organizations are to be used to assist people in need. The items received are not to be sold, bartered, traded or used for profit for the purpose of personal or corporate gain.

Release of All Claims and Liability
